_____ For myself, my heirs and my assigns, I hereby release Tailshakers K9 Adventure Center, its agents, officers, subcontractors, employees, animal parents, customers and potential customers of Tailshakers K9 Adventure Center from any and all liabilities for injuries to myself, my dog, or any other property of mine which arise in any way out of services and/or products provided by or as a consequence of my association with Tailshakers K9 Adventure Center. I acknowledge and understand that every dog reacts differently and that animals, by nature are unpredictable.

_____ Dogs and animals may, without warning, bite or cause injury to humans and other dogs. I acknowledge and understand that there are certain risks involved in participating in daycare, including but not limited into dog fights, dog bites to humans or other dogs and the transmission of disease.

_____ In the case in an emergency or for the use of transportation, I recognize the risks of injury that accompany said transport and acknowledge that this RELEASE is being relied upon by Tailshakers K9 Adventure Center to permit transport of my pet to and from Tailshakers K9 Adventure Center associated with the activities, use of the facilities and transport, and hereby agree to comply with them.

Read and Initial each statement below:

_____ Dogs not familiar with Tailshakers K9 Adventure Center may experience separation anxiety when apart from their human companions

_____ Dogs not regularly exposed to the level of activity at Tailshakers K9 Adventure Center may feel the discomfort of sore muscles, sore joints and fatigue.

_____ Dogs not regularly exposed to outside activity or play on hard surfaces may experience sore paws, blisters, bruises, or abrasions on the feet (Raw Paw) and be excessively tired for 3-7 days.

_____ Dogs not regularly socialized do not necessarily know how to behave politely with other dogs. These dogs are at higher risk of incidents including, but not limited to, bites, fights, fear aggression, object guarding, and behavior problems and/or acting out.

_____ Dogs that play at regular day care do get dirty. Dogs with longer hair can get matted from the level of activity at day care.

_____ Excessively long toenails may cause injury. You will be notified if your dog's nails are too long. If at your next visit, the nails have not been trimmed, Tailshakers K9 Adventure Center will have them trimmed at the parent's expense

_____ I understand the extra risks my puppy has of contacting disease or illness by entering the daycare program with out being fully vaccinated.

_____ Water is available at all times; however, your dog may still be thirsty after day care. Be aware of their water intake as excessive amounts may cause upset stomach or other problems.

_____ Dramatic changes in food and/or food quality may cause upset stomachs, diarrhea, and/or colitis.

_____ Any behavior deemed dangerous or inappropriate by Tailshakers K9 Adventure Center may result in dismissal from the program.

_____ I agree to pay for all services due at the time they are rendered. I understand any unpaid fees by me will be sent to the collections and I will be responsible for all collections and legal fees incurred by such actions taken.

_____ I understand and agree that admitting my dog(s) is/are in good health and has/have not been ill with communicable disease within the last 30 days.

_____ I have read and understand the Tailshakers K9 Adventure Center "Rules and Regulations".

_____ I understand that K9 Tailshakers will keep all personal items in order although in the event of any lost, stolen or damaged items K9 Tailshakers will not be held responsible.

_____ I understand Tailshakers staff give all pets involved in any type of incident a cursory examination, however, Tailshakers K9 Adventure Center is not liable for the location, treatment or diagnosis of any injuries incurred on our premises. It is recommended that you check your dog further or seek treatment for your pet by a licensed veterinarian at your discretion and cost.
